**1. BACKGROUND:**



- (ii) Training curriculum and implementation plan to be designed jointly by both the parties.
- (iii) Resource persons for the training program to be supplied by the BCCI.
- (iv) The training will be conducted through blended mode, online and offline.
- (v) The modalities related to exposure visits under this training need to be fulfilled by BCCI.
- (vi) BGCI would plan for fruitful visit in the respective field of commerce & industry with the focus on practical ground-based knowledge and eventually in the final stage a Certificate of Merit will be provided to the deserving candidates jointly by BCC and BCCI.
- (vii) The course fee of the certificate course shall be utilized for classroom management by BCC. However, no remuneration can be provided to BCCI for teaching classes.
- (viii) Industry-oriented professional programmes and industry-sponsored research projects will be conducted through a collaborative approach by BCC and BCCI. Proposal for professional programme and research project might be recommended by any other side.

### 3. INTERPRETATION AND CONSTRUCTION:

Any ambiguity in the terms and conditions of this Memorandum of Understanding (MoU) resulting in conflicting interpretations shall be settled by both the parties through mutual consultation or negotiation.

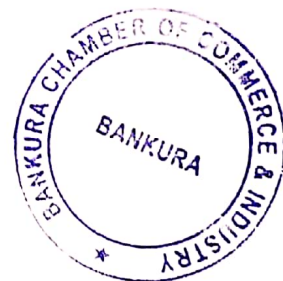
